If you wish to request an Independent Panel Review (IPR) in respect to the decision of Local Governing Body (LGB) upholding the decision of the Executive Principal or Principal to permanently exclude your child from the academy, you need to provide the rationale and justification on the grounds that are legally allowed. An IPR will look at the following elements of the decision of the LGB: illegality, irrationality, procedural impropriety. It has the powers to; uphold the LGB decision, recommend that the decision is reconsidered, or quash the decision and direct that the GB reconsider the matter. *The IPR has no legal powers to overturn a LGBs decision, only to direct the LGB to reconsider, as stated above.*

Therefore, you will need to set out clearly the grounds for an IPR based upon:

- 1. was the decision unlawful?
- 2. was the evidence presented by both parties considered by the LGB in a rationale way?
- 3. was there any procedural impropriety?
